

2015-16 Off Campus Waiver Form

Waiver and release of liability, assumption of risk, and parental consent and indemnity agreement

In consideration of my child, I am permitting him or her to leave campus over a variety of times throughout the school day including but not limited to: lunch; the quiet study period; and to run errands for a class or teacher. I agree to the following:

- 1) I understand the nature and privilege of leaving campus for lunch and the maturity level needed from my student. I believe the student to have such experience, maturity level and capability to leave campus. I further agree, warrant, and will instruct the student that at any time the student believes the conditions to be unsafe, he or she will immediately discontinue the off-campus activity.
- 2) I fully understand that (a) leaving campus at TrekNorth involves risks and dangers of SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, BLINDNESS, PARALYSIS, AND DEATH (risks); (b) These risks and dangers may be caused by the students own actions, or in action's of others participating in the off-campus privilege, of others not associated with TrekNorth Junior and Senior High School, or the condition in which the activity takes place or the negligence of the release name below; (c) There may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of the student leaving campus.
- 3) I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND TO AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS TREKNORTH HIGH SCHOOL, their respective administrators, directors, agents, officers, volunteers, employees, other participants, any sponsors and advertisers, from all liability, claims, demands, part of the negligence of the releases' or otherwise, and further agree that if, despite this release, the student, or anyone on the student's behalf makes a claim against any of the releases' named above, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE, OR COST ANY MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.

I have read this agreement, fully understand its terms, understand that I and my student have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW and agree that if any portion of this agreement is held to be invalid that the balance, notwithstanding, shall continue in full force and effect.
